I am an employee of and receive taxable income from MetroNational Corporation ("MNC"). From time to time, Harris County Municipal Management District No. 1 (the "District") contracts with MNC or its parents, subsidiaries, affiliates or related entities ("MNC Entities"). Specifically, at the time of this filing, the District has ongoing contracts for services with Embark (for landscape and general district maintenance) which is an MNC Entity. Additionally, the District sometimes contracts with Terrace Security Company (for coordination of holiday/special event public safety services), Metro National Corporation (for advertising on shuttle buses), and MNC Mall, Ltd. (for sponsorship of special events), all of which are MNC Entities. In the future, the District may consider additional contracts with MNC Entities or changes to the scope of the existing contracts with MNC Entities. The taxable income I receive from MNC is not directly related to or dependant upon District contracts with MNC Entities. In full compliance with Texas law, I abstain from participation in all votes regarding District contracts with MNC Entities.
