 - b. Security camera installation update;

- 13. Attorney's Report, including:
 - a. Order Amending Records Management Program and Designation of Records Management Officer; and
 - b. Resolution Establishing Addresses and Methods for Texas Public Information Act Requests.

Convene in Executive Session pursuant to: Section 551.071, Texas Government Code, to seek the advice of its attorney regarding pending or contemplated litigation or to seek and receive legal advice from the District's attorney; and Section 551.076, Texas Government Code, to deliberate the deployment, or specific occasions for implementation, of security personnel or devices, or a security audit.
- 15. Reconvene in Open Session and authorize appropriate action.
