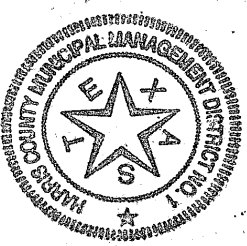
1. Call meeting to order, take attendance and verify a quorum is present.
